BY-LAW

Number 257 - 2017

A By-law to amend the Schedule of Traffic By-law 93-93, relating to FIRE ROUTES (Schedule XXII), SCHOOL BUS LOADING ZONES (Schedule VIII), NO PARKING (Schedule XIV), THROUGH HIGHWAYS (Schedule III), STOP SIGNS (Schedule IV), NO PARKING LOADING ZONES (Schedule XXXIII), PAY AND DISPLAY ZONES (Schedule XXXII) and DESIGNATED TURNING LANES (Schedule VI)

WHEREAS the Council for The Corporation of the City of Brampton has adopted the Traffic and Parking By-law No. 93-93, ("By-law 93-93") as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the *Municipal Act, 2001* a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending Schedule XXII (FIRE ROUTES), Schedule VIII (SCHOOL BUS LOADING ZONES), Schedule XIV (NO PARKING), Schedule III (THROUGH HIGHWAYS), Schedule IV (STOP SIGNS), Schedule XXXIII (NO PARKING LOADING ZONES), Schedule XXXII (PAY AND DISPLAY ZONES) and Schedule VI (DESIGNATED TURNING LANES);

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule XXII:


