BY-LAW

Number 271 - 2017

To amend the Schedule of Traffic By-law 93-93, relating to THROUGH HIGHWAYS (Schedule III) and STOP SIGNS (Schedule IV)

WHEREAS the Council for The Corporation of the City of Brampton has adopted the Traffic and Parking By-law No. 93-93, ("By-law 93-93") as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the *Municipal Act, 2001* a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending Schedule III (THROUGH HIGHWAYS) and Schedule IV (STOP SIGNS);

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended by ADDING the following item to Schedule III:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY

Westbrook Avenue

Westbrook Avenue

COLUMN 2 BETWEEN

The south limit of Cottrelle Boulevard and the north limit of Whitehouse Crescent/Avalanche Crescent (northerly intersection)

The south limit of Whitehouse Crescent/Avalanche Crescent (northerly intersection) and the north limit of Don Minaker Drive.

2. By-law 93-93 as amended, is hereby further amended by DELETING the following item from Schedule III:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Westbrook Avenue	The south limit of Cottrelle Boulevard and the south limit of Whitehouse Crescent/Avalanche Crescent (southerly intersection)

3. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule IV:

STOP SIGNS

COLUMN 1 INTERSECTION or LOCATION	COLUMN 2 FACING TRAFFIC
Avalanche Crescent/ Whitehouse Crescent and Westbrook Avenue (northerly intersection)	Northbound on Westbrook Avenue
Avalanche Crescent Whitehouse Crescent and Westbrook Avenue (northerly intersection)	Southbound on Westbrook Avenue
Avalanche Crescent Whitehouse Crescent and Westbrook Avenue (northerly intersection)	Eastbound on Whitehouse Crescent
Avalanche Crescent Whitehouse Crescent and Westbrook Avenue (northerly intersection)	Westbound on Avalanche Crescent
