

## THE CORPORATION OF THE CITY OF BRAMPTON

**BY-LAW** 

Number <u>173</u>-2018

To amend Interim Control By-Law 246-2017, An Interim Control By-law Applicable to Part of the Area Subject to Zoning By-Law 270-2004, as amended, to permit a motor vehicle body shop use and a motor vehicle repair shop use within the lands known municipally as 60 Eastern Avenue.

The Council of the Corporation of the City of Brampton ENACTS as follows:

- 1. By-Law 246-2017, as amended, is hereby further amended by adding the following new Section 1.2:
  - \*1.2 Nothing in this By-law shall prohibit the use of a motor vehicle body shop and a motor vehicle repair shop to operate within the existing building on the lands known municipally as 60 Eastern Avenue, described as Part of Lot 5, Concession 2, E.H.S Brampton, Ontario, subject to the following restrictions:
    - The maximum combined gross floor area of the motor vehicle body shop and motor vehicle repair shop shall be 255 square metres (2,745 square feet); and,
    - (ii) The only motor vehicles permitted to be body shopped or repaired are those motor vehicles that will be offered for sale at 60 Eastern Avenue."
