BY-LAW

Number 33 - 2019

To amend the Schedule of Traffic By-law 93-93, relating to THROUGH HIGHWAYS (Schedule III) and STOP SIGNS (Schedule IV)

WHEREAS the Council for The Corporation of the City of Brampton has adopted the Traffic and Parking By-law No. 93-93, ("By-law 93-93") as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the *Municipal Act, 2001* a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending (Schedule III) THROUGH HIGHWAYS and (Schedule IV) STOP SIGNS;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended by ADDING the following item to Schedule III:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Clayborne Avenue	The west limit of Leagrove Street and the west limit of Leagate Street
Clayborne Avenue	The east limit of Leagate Street and the west limit of Kershaw Street

2. By-law 93-93 as amended, is hereby further amended by DELETING the following item from Schedule III:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Clayborne Avenue	The west limit of Leagrove Street and the west limit of Kershaw Street

3. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule IV:


STOP SIGNS

COLUMN 1 INTERSECTION or LOCATION	COLUMN 2 FACING TRAFFIC
Clayborne Avenue and Leagate Street	Eastbound on Clayborne Avenue
Clayborne Avenue and Leagate Street	Westbound on Clayborne Avenue
Clayborne Avenue and Leagate Street	Northbound on Leagate Street
Clayborne Avenue and Leagate Street	Southbound on Leagate Street
