
To Adopt Amendment Number OP 2006- **\58** to the Official Plan of the City of Brampton Planning Area

AMENDMENT NUMBER OP 2006 – 158 To Official Plan of the City of Brampton Planning Area

AMENDMENT NUMBER OP 2006 – (58 TO THE OFFICIAL PLAN OF THE CITY OF BRAMPTON PLANNING AREA

1.0 <u>Purpose:</u>

The purpose of this amendment is to delete the lands shown on Schedule 'A' to this amendment from the Huttonville North Secondary Plan (Area 52) and to add them to Area 29 (b) of the Huttonville Secondary Plan and designate the lands as "Low Density Residential" and "Natural Heritage System" to permit development of the lands for residential purposes.


2.0 Location:

The lands subject to this amendment are generally located between Mississauga Road and Heritage Road and north of Embleton Road as shown on Schedule 'A' to this amendment. The lands are located immediately west of the Four X Development draft approved Plan of Subdivision (21T-10002B) within Secondary Plan Area 29(b). The lands are described as Part of Lot 7 and 8, Concession 5, W.H.S.

3.0 Amendments and Policies Relative Thereto:

- 3.1. The document known as the Official Plan of the City of Brampton is hereby amended:
 - By amending Schedule 'G' SECONDARY PLAN AREAS to remove the subject lands from the Huttonville North Secondary Plan (Area 52) and add the lands to Area 29 (b) of the Huttonville Secondary Plan as shown on Schedule 'C' to this amendment.
 - By adding to the list of amendments pertaining to Part II: Chapter 29(b) thereof, Amendment Number OP 2006-158
- 3.2. The document known as the Huttonville Secondary Plan, being Chapters 29(a) and 29(b) of Part II of the Official Plan of the City of Brampton, as amended, is hereby further amended:
 - (1) By adding the subject lands to Schedule SP29(a) as shown on Schedule 'B' to this amendment.
 - (2) By adding the subject lands to Schedule SP29(b) and designating the lands as 'Low Density Residential' and 'Natural Heritage System' as shown on Schedule 'A' to this amendment.





AND IN THE MATTER OF the City of Brampton By-law 95-2019 being a by-law to adopt Official Plan Amendment OP2006-158, and By-law 96-2019 to amend Zoning By-law 270-2004, as amended – KLM Planning Partners Inc. – Four X Developments Inc. (C05W07.006)

DECLARATION

I, Charlotte Gravlev, Deputy City Clerk, City of Brampton, in the Region of Peel, hereby make oath and say as follows:

- 1. I am the Deputy City Clerk of The Corporation of the City of Brampton and as such have knowledge of the matters herein declared.
- By-law 95-2019 was passed by the Council of the Corporation of the City of Brampton at its meeting on the 8th day of May, 2019, to adopt Amendment Number OP2006-158 to the 2006 Official Plan.
- 3. By-law 96-2019 was passed by the Council of the Corporation of the City of Brampton at its meeting held on the 8th day of May, 2019, to amend Zoning By-law 270-2004, as amended.
- 4. Written notice of By-law 95-2019 as required by section 17(23) of the *Planning Act* was given on the 15th day of May, 2019, in the manner and in the form and to the persons and agencies prescribed by the *Planning Act, R.S.O. 1990* as amended.
- 5. Written notice of By-law 96-2019 as required by section 34(18) of the *Planning Act* was given on the 15th day of May, 2019, in the manner and in the form and to the persons and agencies prescribed by the *Planning Act, R.S.O. 1990* as amended.
- 6. No notice of appeal was filed under section 17(24) and section 34(19) of the *Planning Act* on or before the final date for filing objections.
- 7. In all other respects, the Official Plan Amendment and Zoning By-law have been processed in accordance with all of the *Planning Act* requirements including regulations for notice.
- 8. OP2006-158, adopted by By-law 95-2019, is deemed to have come into effect on the 8th day of May, 2019, in accordance with Section 17(27) of the *Planning Act*, *R.S.O. 1990,* as amended.
- 9. Zoning By-law 96-2019 is deemed to have come into effect on the 8th day of May, 2019, in accordance with Section 34(21) of the *Planning Act, R.S.O.* 1990, as amended.

And I make this solemn declaration conscientiously believing it to be true and knowing that it is of the same force and effect as if made under oath.
