BY-LAW

Number 190 - 2019

To amend the Schedules of Traffic By-law 93-93, relating to THROUGH HIGHWAYS (Schedule III) and STOPS SIGNS (Schedule IV)

WHEREAS the Council for The Corporation of the City of Brampton has adopted the Traffic and Parking By-law No. 93-93, ("By-law 93-93") as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the *Municipal Act, 2001* a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending THROUGH HIGHWAYS (Schedule III) and STOP SIGNS (Schedule IV);

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule III:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Creditview Road	The south limit of James Potter Road and the south limit of Kalmia Road
Trueman Street	The south limit of John Street and the south limit of Eastern Avenue

2. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule III:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Creditview Road	The south limit of James Potter Road and north limit of Valleyway Drive

Creditview Road	The south limit of Valleyway Drive and south limit of Kalmia Road
Trueman Street	The south limit of John Street and the north limit of Eastern Avenue

3. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule IV:


STOP SIGNS

COLUMN 1 INTERSECTION or LOCATION	COLUMN 2 FACING TRAFFIC
Creditview Road and Valleyway Drive	Northbound on Creditview Road
Creditview Road and Valleyway Drive	Southbound on Creditview Road
Creditview Road and Valleyway Drive	Eastbound on Valleyway Drive
Creditview Road and Valleyway Drive	Westbound on Valleyway Road
Eastern Avenue and Trueman Street	Northbound on Trueman Street
Eastern Avenue and Trueman Street	Southbound on Trueman Street
Eastern Avenue and Trueman Street	Westbound on Eastern Avenue


