BY-LAW

Number 220 - 2019

To amend The Screening and Hearing Officer By-law 334-2013

WHEREAS The Corporation of the City of Brampton has enacted an Administrative Monetary Penalty System for parking related offences pursuant to section 102.1 of the *Municipal Act, 2001*, S.O. 2001, c. 25 (the "*Municipal Act*").

AND WHEREAS The Corporation of the City of Brampton has enacted an Administrative Monetary Penalty System for non-parking related offences pursuant to section 434.1 of the *Municipal Act* and section 15.4.1 of the *Building Code Act, 1992*, S.O. 1992, c. 23.

AND WHEREAS The Corporation of the City of Brampton considers it desirable to appoint a common set of Hearing and Screening Officers to conduct reviews of penalty notices issued in respect of offences designated pursuant to section 102.1 and 434.1 of the *Municipal Act*, and section 15.4.1 of the *Building Code Act*.

NOW THEREFORE The Corporation of the City of Brampton enacts as follows:

1. That By-Law 334-2013, as amended, be further amended to add the following recitals:

Section 434.1 of the *Municipal Act, 2001*, S.O. 2001, c. 25 (the "*Municipal Act*") authorizes a municipality to require a person, subject to such conditions as the municipality considers appropriate, to pay an administrative penalty if the municipality is satisfied that the person has failed to comply with a by-law of the municipality passed under the *Municipal Act, 2001*, in order to assist the municipality in promoting compliance with its by-laws.

Section 15.4.1 of the *Building Code Act, 1992*, S.O. 1992, c. 23 (the "*Building Code Act*") authorizes a municipality to require a person, subject to such conditions as the municipality considers appropriate, to pay an administrative penalty if the municipality is satisfied that the person has failed to comply with a by-law passed under section 15.1 of the *Building Code Act* or an order issued under section 15.2(2) of the *Building Code Act*.

2. That By-Law 334-2013, as amended, is further amended by deleting the definition of "Administrative Penalty By-Law" in paragraph 2 of By-law 334-2013 and replacing it with the following:

“Administrative Penalty By-laws” means the Administrative Penalty By-law 333-2013 and the Administrative Penalties By-Law (Non-Parking) ~~218~~ - 2019, as may be amended from time to time, adopted by Council.”


3. That By-Law 334-2013, as amended, is further amended by replacing all references to “Administrative Penalty By-law” with the words “Administrative Penalty By-laws”.
4. This By-law shall come into force and effect on January 1, 2020.
