Number 241 - 2019

A By-law To Authorize Civil Marriage Solemnization Services and
To Appoint Civil Marriage Officiants

WHEREAS the *Marriage Act*, R.S.O. 1990, c. M.3 and R.R.O. 1990, Reg. 738, as amended, permits the Clerk of a municipality to issue marriage licenses and to perform civil marriages solemnizations;

AND WHEREAS on July 8, 2015 the Council of the Corporation of the City of Brampton authorized the Clerk to offer civil marriage solemnization services by the City of Brampton and wishes to continue to provide civil marriage solemnization services;

AND WHEREAS the *Municipal Act, 2001*, S.O. 2001, as amended, permits the Clerk to delegate in writing to any person, other than a member of council, any of the clerk's powers and duties under that *Act* or any other *Act*, and permits a municipality to set fees and charges in respect of services performed and costs incurred in the performance of such services by a municipality;

AND WHEREAS the Council of the Corporation of the City of Brampton wishes to appoint municipal staff delegated by the Clerk as additional municipal civil marriage officiants to provide civil marriage solemnization services in accordance with the *Marriage Act*;

NOW THEREFORE the Council of The Corporation of the City of Brampton **ENACTS** as follows:

PART I – SHORT TITLE

1. This By-law may be referred to as the “Civil Marriage Solemnization By-law”.

PART II – DEFINITIONS

2. For the purposes of this By-law:

“City” means The Corporation of the City of Brampton;

“Clerk” means the Clerk of the City, or his or her delegate;

“Council” means the elected Council of the City;

“*Marriage Act*” means *Marriage Act*, R.S.O. 1990, c. M.3 and the regulations enacted thereunder;

“Civil Marriage Solemnization” means the civil solemnization of a marriage in accordance with the *Marriage Act*;

“Civil Marriage Officiant” means a person listed in Schedule “A” hereto who is authorized under this By-law to perform Civil Marriage Solemnizations on behalf of the City in accordance with the *Marriages Act*.

PART III – CIVIL MARRIAGE SOLEMNIZATION SERVICES

3. The City shall continue to provide Civil Marriage Solemnization services.
4. The Clerk shall direct the dates, times and locations when Civil Marriage Solemnization services shall be provided by the City.
5. The fees for Civil Marriage Solemnization services shall be charged in accordance with the City’s User Fee By-law 380-2003, Schedule C, as amended.


PART IV – APPOINTMENT OF CIVIL MARRIAGE OFFICIANTS


