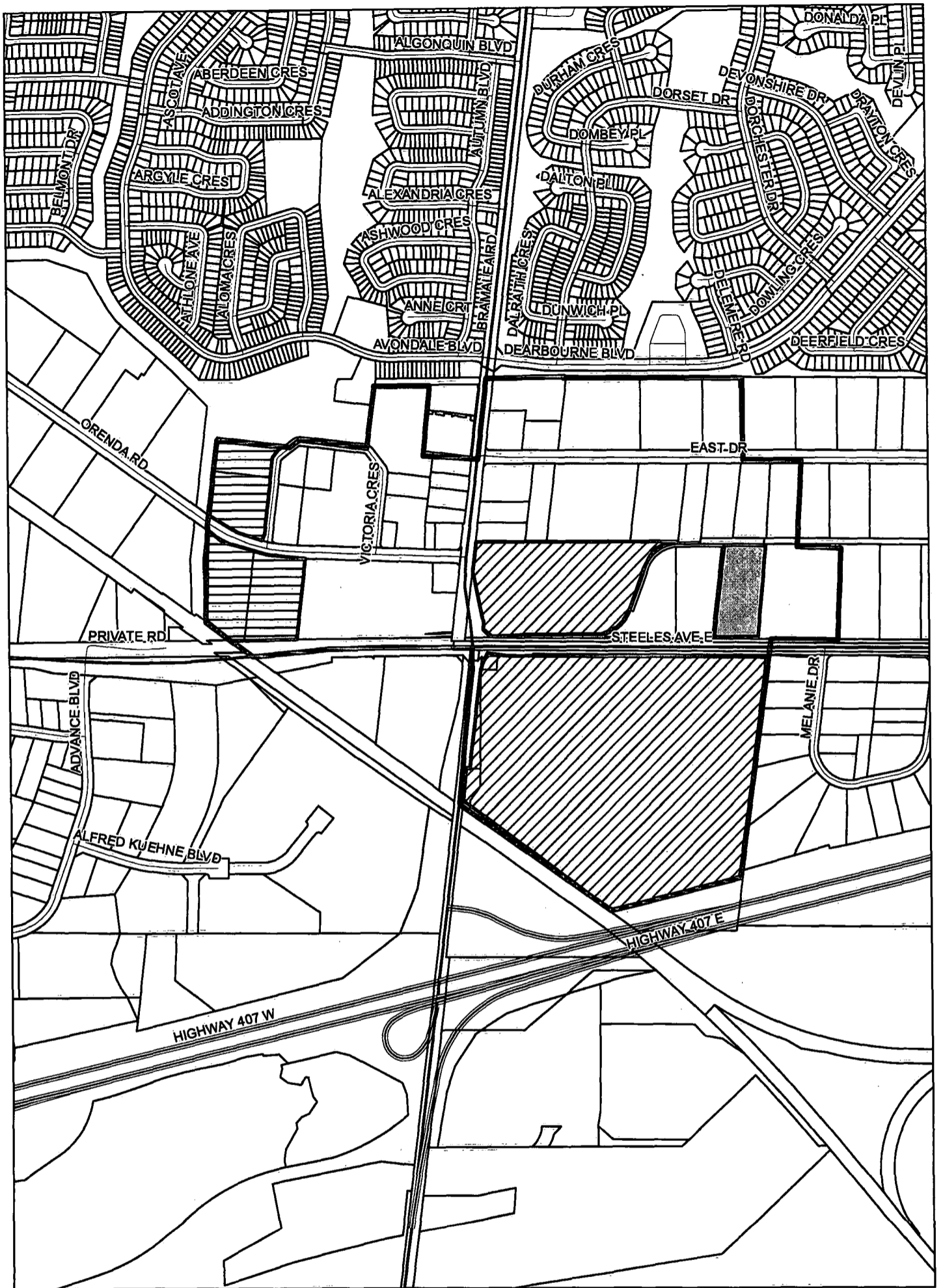

DECLARATION


I, Charlotte Gravlev, Deputy City Clerk, City of Brampton, in the Region of Peel, hereby
