BY-LAW

Number 18 - 2020

To amend the Schedules of Traffic By-law 93-93, relating to THROUGH HIGHWAYS (Schedule III) and STOPS SIGNS (Schedule IV)

WHEREAS the Council for The Corporation of the City of Brampton has adopted the Traffic and Parking By-law No. 93-93, ("By-law 93-93") as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the *Municipal Act, 2001* a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending THROUGH HIGHWAYS (Schedule III) and STOP SIGNS (Schedule IV);

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following item from Schedule III:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Abitibi Lake Drive	The west limit of the roadway and the west limit of Everingham Circle

2. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule III:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Abitibi Lake Drive	The east limit of Fernforest Drive and the west limit of Fairservice Drive

Abitibi Lake Drive	The east limit of Fairservice Drive and the west limit of Everingham Circle (easterly intersection)
Fairservice Drive	The south limit of Countryside Drive and the north limit of Abitibi Lake Drive
Fairservice Drive	The south limit of Abitibi Lake Drive and the north limit of Father Tobin Road

3. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule IV:


STOP SIGNS

COLUMN 1 INTERSECTION or LOCATION	COLUMN 2 FACING TRAFFIC
Abitibi Lake Drive and Fairservice Drive	Northbound on Fairservice Drive
Abitibi Lake Drive and Fairservice Drive	Southbound on Fairservice Drive
Abitibi Lake Drive and Fairservice Drive	Eastbound on Abitibi Lake Drive
Abitibi Lake Drive and Fairservice Drive	Westbound on Abitibi Lake Drive
