



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 126 - 2020

To amend the Schedules of Traffic By-law 93-93, relating to THROUGH HIGHWAYS (Schedule III), RATE OF SPEED (Schedule X), NO PARKING (Schedule XIV), FIRE ROUTES (Schedule XXII), COMMUNITY SAFETY ZONES (Schedule XXIV) and INTERSECTION SIGHTLINE TRIANGLE (XLI)

WHEREAS the Council for The Corporation of the City of Brampton has adopted the Traffic and Parking By-law No. 93-93, ("By-law 93-93") as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the *Municipal Act, 2001* a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending THROUGH HIGHWAYS (Schedule III), RATE OF SPEED (Schedule X), NO PARKING (Schedule XIV), FIRE ROUTES (Schedule XXII), COMMUNITY SAFETY ZONES (Schedule XXIV) and INTERSECTION SIGHTLINE TRIANGLE (XLI);

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule III:


