



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 160 - 2020

To amend the Schedules of Traffic By-law 93-93, relating to U-TURNS (Schedule II), RATE OF SPEED (Schedule X), NO PARKING (Schedule XIV), NO STOPPING (Schedule XV), FIRE ROUTES (Schedule XXII), COMMUNITY SAFETY ZONES (XXIV), PARKING METERS PAY AND DISPLAY (Schedule XXVI), BARRIER CONTROLLED (Schedule XXVII), PERMIT ONLY OPERATION (XXVIII), and NO PARKING LOADING ZONES (Schedule XXXIII)

WHEREAS the Council for The Corporation of the City of Brampton has adopted the Traffic and Parking By-law No. 93-93, ("By-law 93-93") as amended to regulate the use of highways and parking in the City of Brampton;

AND WHEREAS pursuant to subsection 11 (3) 1 of the *Municipal Act, 2001* a by-law may be passed by a council of a municipality relating to the regulation of highways and parking within the municipality;

AND WHEREAS the Council of The Corporation of the City of Brampton is desirous of adopting a by-law to further amend By-law 93-93 by amending U-TURNS (Schedule II), RATE OF SPEED (Schedule X), NO PARKING (Schedule XIV), NO STOPPING (Schedule XV), FIRE ROUTES (Schedule XXII), COMMUNITY SAFETY ZONES (XXIV), PARKING METERS PAY AND DISPLAY (Schedule XXVI), BARRIER CONTROLLED (Schedule XXVII), and PERMIT ONLY OPERATION (XXVIII);

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:


