



**Office Consolidation  
Municipal Officials By-law 84-2008**

**To appoint Municipal Officials and to repeal By-laws 308-83, 23-85, 87-91, 20-2000, 6-2001, 56-2002, 291-2002, 156-2003, 244-2003, 333-2003, 67-2006, 68-2006, 82-2007, 22-2008, 74-2008**

WHEREAS the municipality is required to appoint certain officials, and has authority to appoint others; and

WHEREAS it is expedient to consolidate existing appointments into one by-law;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. (1) That David Barrick be and is appointed as Chief Administrative Officer (also known as City Manager) and shall exercise all powers and duties of the position for all purposes under the *Municipal Act, 2001*, City by-laws and policies. **(By-laws 278-2012, 73-2015, 93-2015, 52-2016, 10-2019, 183-2019, 266-2019)**
- (2) Where the Chief Administrative Officer is absent from his duties for any reason, a Department Commissioner or Head as designated in writing by the Chief Administrative Officer is authorized to act in the place of the Chief Administrative Officer and shall exercise all the powers and duties as set out in subsection (1). **(By-laws 73-2015, 93-2015, 52-2016, 1-2017)**

3. That Michael Won be appointed as Acting Commissioner, Public Works and Engineering Department. (**By-laws 243-2013, 171-2016, 10-2019, 183-2019**)
4. That Al Meneses be appointed as Commissioner, Community Services Department. (**By-laws 243-2013, 171-2016**)
5. That Richard Forward be appointed as Commissioner, Planning and Development Services Department. (**By-laws 243-2013, 171-2016, 103-2017, 183-2019**)
6. That Joe Pittari be appointed as Commissioner, Corporate Services Department. (**By-laws 243-2013, 171-2016, 1-2017**)
7. That Alex Milojevic be appointed as General Manager, Brampton Transit Department. (**By-laws 143-2013, 1-2017, 103-2017**)
8. (a) That David Sutton be appointed as Treasurer and is hereby delegated all of the powers and duties of the Treasurer with respect to the collection of taxes. (**By-laws 243-2013, 171-2016, 1-2017, 192-2017**)
  - (a) That Zeeshan Majid be appointed as Deputy Treasurer. (**By-law 192-2017**)
9. (a) That Bill Boyes be appointed as Fire Chief; (**By-laws 231-2014, 192-2017**)
  - (b) That Peter Gatto and Kim Kane be appointed as Deputy Fire Chiefs. (**By-laws 139-2016, 192-2017**)
10. That Clare Barnett be appointed as Director, Economic Development and Culture Department. (**By-laws 190-2013, 1-2017, 183-2019**)
11. (a) That Peter Fay be appointed as City Clerk, and (**By-laws 113-2009, 192-2017**)
  - (b) That Charlotte Gravlev be appointed Deputy City Clerk, Legislative Services, and (**By-law 192-2017**)
  - (c) That Janice Adshead be appointed Deputy City Clerk, Records and Information Management. (**By-law 192-2017**)
12. (a) (i) That John Zingaro and Diana Soos be appointed as Acting City Solicitor to carry out the duties of the City Solicitor while the position is vacant, on a rotating two (2) week basis respectively, starting with Diana Soos for the two week period commencing July 20 to August 2, 2019, and continuing with John Zingaro for the two week period commencing August 3 to 16,

2019, and alternating in like manner thereafter. **(By-laws 139-2016, 192-2017, 152-2019)**

- (ii) That should a Deputy City Solicitor be unable to carry out the duties of Acting City Solicitor for any time during a period of such appointment, the other Deputy City Solicitor shall serve as Acting City Solicitor in his or her stead for such time. **(By-law 152-2019)**
  - (iii) That should neither Deputy City Solicitor be able to carry out the duties of Acting City Solicitor for any time during his or her appointment hereunder, the Chief Administrative Officer may appoint a legal counsel in the Legal Services division to serve as Acting City Solicitor during such time. **(By-law 152-2019)**
  - (b) That John Zingaro be appointed as Deputy City Solicitor, Real Property, Commercial and Development Law, and **(By-laws 139-2016, 171-2016, 192-2017)**
  - (c) That Diana Soos be appointed as Deputy City Solicitor, Litigation and Administrative Law. **(By-law 192-2017)**
13. That By-laws 308-83, 23-85, 87-91, 20-2000, 6-2001, 56-2002, 291-2002, 156-2003, 244-2003, 333-2003, 67-2006, 68-2006, 82-2007, 22-2008 and 74-2008, all as may be amended, are hereby repealed.
