WHEREAS the Council of The Corporation of the City of Brampton bas, by resolution, decided that all works constructed and installed in accordance with the subdivision agreement for Registered Plan 43M-169 be accepted and assumed.


AND WHEREAS Council has authorized the City Treasurer to release all securities held by the City in connection with the development of Registered Plan 43M-169.

AND WHEREAS it is deemed expedient to accept and assume the streets (and street)widenings, when applicable) on Registered Fian 43M-169 as part of the public highway system (and to establish certain other lands as public highways, when applicable).

NOW THEREFORE the Council of The Corporation of the City of Brampton hereby ENACTS as follows:

- All of the works constructed and installed in accordance with the subdivision agreement for Registered Plan 43M-109 are mereby accepted and assumed.
- The tands described in Schedule A to this by-law are hereby accepted and assumed as part of the public highway system of the City of Brampton. 2.
- The lands acquired by the City of Brampton and described in Schedule B. to this by law are hereby established as parts of public highways. 3.
