A By-law to amend By-law 308-2012, being the
"Building Division Appointment By-law"

RECITALS:

WHEREAS Subsection 3(2) of the *Building Code Act*, 1992, S.O. 1992, c.23, as amended requires the Council of each municipality to appoint a Chief Building Official and such inspectors as are necessary for the purposes of the enforcement of the *Building Code Act*, 1992;

WHEREAS Section 15 of the *Police Services Act*, R.S.O. 1990, c. P.15, as amended, authorizes a municipal council to appoint Municipal By-law Enforcement Officers, who shall be peace officers for the purpose of enforcing municipal by-laws;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. Schedule 1 of By-law 308-2012, is amended as follows:
 - (a) Hammond, C. is **deleted** from the list.
 - (b) Luis, P. and Nguyen, D. are **added** to the list.
 - (c) Dalal, N. not Dalai, N. is **amended**.
2. Schedule 2 of By-law 308-2012, is amended as follows:
 - (a) Hammond, C. is **deleted** from the list.
 - (b) Athar, S., Luis, P., and Ngyen, D. are **added** to the list.
 - (c) Dalal, N. not Dalai, N. is **amended**.
3. Attached as Schedule 1 and 2 to this By-law are revised schedules that set out the changes listed in sections 1 and 2 of this By-law and these schedules shall replace Schedule 1 and 2 in By-law 308-2012, as amended.




City Council Meeting – Adoption of By-laws
