Number 3-88

To change the name of parts
of Nelson Street

WHEREAS the Council of the City of Brampton deems it expedient to change the name of parts of Nelson Street;

AND WHEREAS notice of the intention to pass this by-law has been published once a week for four successive weeks in The Brampton Times, a newspaper having general circulation in the City of Brampton;


AND WHEREAS the Council has heard all persons who claimed that they would be adversely affected by this by-law and who applied to be heard;

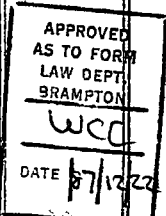
NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. The name of the part of Nelson Street described firstly in Schedule A to this by-law is hereby changed to "Wilson Avenue".
2. The name of the part of Nelson Street described secondly in Schedule A to this by-law is hereby changed to "Dusty Lane".
3. The affidavit of Leonard J. Mikulich attached as Schedule B hereto shall form part of this by-law.

READ A FIRST, SECOND AND THIRD TIME, and PASSED, in open Council this 11th day of January, 1988.

SCHEDULE A to By-law 3-88

FIRSTLY:

The land situated in the City of Brampton, in the Regional Municipality of Peel (formerly in the Town of Brampton, County of Peel) being composed of the part of Nelson Street according to Registered Plan BR-13, situated east of Centre Street as shown on said Plan BR-13.

SECONDLY:

The land situated in the City of Brampton, in the Regional Municipality of Peel (formerly in the Township of Chinguacousy, County of Peel) being composed of the part of Nelson Street according to Registered Plan G-23 adjacent to Blocks A and B on Plan G-23 (said land being situated west of the creek shown on Plan G-23)

SCHEDULE B to By-law 3-88

I, LEONARD J. MIKULICH, City Clerk and Director of Administration for The Corporation of the City of Brampton, MAKE OATH AND SAY THAT:

1. A public notice respecting the street name change of parts of Nelson Street was advertised, in the form attached as Exhibit A to my affidavit, in the Brampton Times on the following dates:

- iii) Monday, January 4, 1988; and
- iv) Monday, January 11, 1988.
