To establish certain lands as part of the public highway (Brampton Brick Subdivision)

The Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

- 1. The lands acquired by The Corporation of the City of Brampton and being composed of the part of Lot 10, Concession 1 East of Hurontario Street designated as Parts 1, 2, 3 and 4 on a reference plan deposited in the Land Registry Office of the Land Titles Division of Peel as No. 43R-21039, are hereby established as part of the public highway system.
- 2. The lands designated as Part 1 on Plan 43R-21039 shall be part of Hurontario Street. The lands designated as Parts 2 and 3 on Plan 43R-21039 shall be part of Quarry Edge Drive. The lands designated as Part 4 on Plan 43R-21039 shall be part of Yellow Brick Road.
