**To amend By-law 93-93,
NO PARKING, NO STOPPING, FIRE ROUTES
RATE OF SPEED, THROUGH HIGHWAYS**

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from Schedule XIV thereto the following items:


