BY-LAW NUMBER 7 - 75

A By-law to authorize a capital expenditure in the amount of \$55,000.00 for the construction of certain sidewalks.


WHEREAS the Council of the Corporation of the City of Brampton desires to undertake the construction of certain sidewalks in the City of Brampton;

NOW THEREFORE the Council of the Corporation of the City of Brampton ENACTS as follows:

1. That the Council of the Corporation of the City of Brampton shall undertake the construction of concrete sidewalks on those streets and in the locations shown on Schedule "A" hereto attached as a capital expenditure at an estimated cost of \$55,000.00.
2. That the Mayor and the Treasurer are hereby authorized in the name of and on behalf of the Corporation to borrow from time to time by way of promissory note from the Royal Bank of Canada, 1 Main Street North, Brampton, a sum or sums not exceeding in the aggregate \$55,000.00 for the aforementioned purpose and to give on behalf of the Corporation to the Royal Bank of Canada a promissory note or notes sealed with the Corporate Seal and signed by the Mayor and the Treasurer for the money so borrowed with interest which may be paid in advance or otherwise.

READ A FIRST, SECOND and THIRD TIME and PASSED in Open Council this 13th day of January , 1975.

7. Queen Street West from McLaughlin Road to Kimbark Drive	1800 feet	North
8. Cathedral Road from Bartley Bull Parkway to Nanwood Drive	1000 feet	West

10. Eldomar Avenue from Meadowland Drive to West Limit of Eldomar Avenue	200 feet	North Side

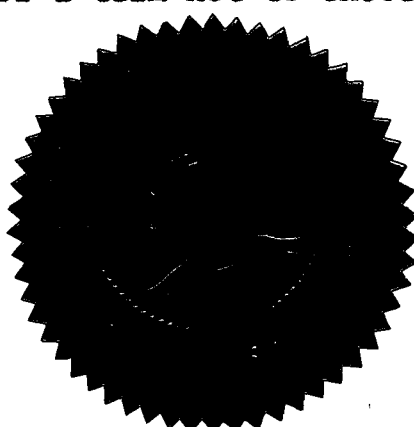
