BY-LAW NUMBER 9 - 75

A By-law to authorize a capital expenditure in the amount of \$275,000.00 for the construction of certain street lighting.


WHEREAS the Council of the Corporation of the City of Brampton desires to undertake the construction of certain street lighting in the City of Brampton;


NOW THEREFORE the Council of the Corporation of the City of Brampton ENACTS as follows:

1. That the Council of the Corporation of the City of Brampton shall undertake the construction of street lighting on those streets shown on Schedule "A" hereto attached as a capital expenditure at an estimated cost of \$275,000.00.

2. That the Mayor and the Treasurer are hereby authorized in the name of and on behalf of the Corporation to borrow from time to time by way of promissory note from the Royal Bank of Canada, 1 Main Street North, Brampton, a sum or sums not exceeding in the aggregate \$275,000.00 for the aforementioned purpose and to give on behalf of the Corporation to the Royal Bank of Canada a promissory note or notes sealed with the Corporate Seal and signed by the Mayor and the Treasurer for the money so borrowed with interest which may be paid in advance or otherwise.

SCHEDULE "A" TO BY-LAW NO. 9 - 75

1. Arterial oversizing in Peel Manor, Kennedy Manor, Sunrose and Coventry subdivisions.
2. All streets as presently developed in Industrial #7 area.
3. Glidden Road, westerly 500 feet from Heart Lake Road.
4. McMurphy Avenue, Queen Street to Kingsview Avenue.
5. Steeles Avenue - Main Street to Dixie Road, South Side.
6. Queen Street West - 200 feet West of McLaughlin Road to 4th Line West.
7. Vodden Street - Main Street to Kennedy Road.
8. Intersection Lighting - various non-urban locations.
9. Kennedy Road - Steeles Avenue to W.J. Fenton School.
10. Bramalea Road - Williams Parkway to #10 Sideroad.
11. Dixie Road - Steeles Avenue to Highway #7 - West Side.
12. Kennedy Road North - Vodden Street to North City Limit.

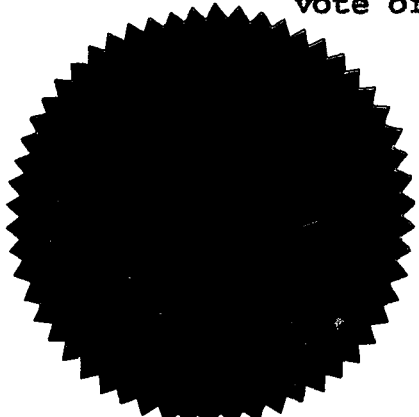

THE BOARD ORDERS that this application be granted and that the applicant may proceed with the installation of street lighting on various streets described in Schedule "A" attached hereto and may pass all requisite by-laws, and The Regional Municipality of Peel may issue debentures therefor for a sum not exceeding \$275,000.00 and not to exceed the net cost of such undertaking to the applicant, for a term not to exceed twenty years, provided that any by-law authorizing the undertaking is passed by a three-fourths vote of all members of the council of the applicant corporation.

INSTALLATION of STREET LIGHTING on the following streets:

1. Arterial oversizing in Peel Manor, Kennedy Manor, Sunrose and Coventry subdivisions.
2. All streets as presently developed in Industrial Number 7 area.
3. Glidden Road, westerly 500 feet from Heart Lake Road.
4. McMurphy Avenue, Queen Street to Kingsview Avenue.
5. Steeles Avenue - Main Street to Dixie Road, South Side.
6. Queen Street West - 2000 feet West of McLaughlin Road to 4th Line West.
7. Vodden Street - Main Street to Kennedy Road.
8. Intersection Lighting - various non-urban locations.
9. Kennedy Road - Steeles Avenue to W.J. Fenton School.
10. Bramalea Road - Williams Parkway to Number 10 Sidroad.
11. Dixie Road - Steeles Avenue to Highway Number 7 - West Side.
12. Kennedy Road North - Vodden Street to North City Limit.
