To amend By-law 861, as amended,
of the former Township of
Chinguacousy, now in the City
of Brampton

The Council of The Corporation of the City of Brampton hereby
ENACTS as follows:

1. By-law 861, as specifically amended by By-law 229-80, is
amended:

(1) by deleting the parts of Schedule A added thereto
by By-law 229-80, and identified as Schedules H, J,
K, L, M and N to By-law 229-80, and substituting
therefor Schedules 1, 2, 3, 4, 5 and 6 to this
by-law;

(2) by deleting the part of Schedule A added thereto
by By-law 229-80, and identified as Schedule Q to
By-law 229-80;

(3) by adding thereto, as part of Schedule A, Schedules
7, 8 and 9 to this by-law;

(4) by deleting subsection (2)(f) of section 16K and
substituting therefor the following:

"(f) Minimum Rear Yard Depth:	6 metres, except where the rear yard abuts a Residential or Institutional zone, the minimum rear yard depth shall be 9 metres."

(5) by adding thereto the following sections:

"304 The land designated as HC-SECTION 304 on
Schedule A hereto attached:

304.1 shall only be used for:

- (1) an automobile service station,
- (2) a farm equipment sales dealership, and
- (3) one apartment on the second floor.

304.2 shall be subject to the requirements and restrictions set out in Section 16J(3).

305 The lands designated HC-SECTION 305 on Schedule A hereto attached:

305.1 shall only be used for the following purposes:


- (1) an automobile service station,
- (2) a grocery store,
- (3) an animal hospital, and
- (4) one apartment on the second floor.

305.2 shall be subject to the requirements and restrictions set out in Section 16J(3)."




Part Lot 1, Concession 4 E.H.S.






