WHEREAS THE COUNCIL OF THE CORPORATION OF THE CITY OF BRAMPTON DEEMS IT EXPEDIENT AND ADVISABLE TO AMEND BY-LAW NUMBER 234-75, BEING A BY-LAW DESIGNATING SCHOOL BUS LOADING ZONES.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF BRAMPTON HEREBY ENACTS AS FOLLOWS :

1. THAT SCHEDULE "A" TO BY-LAW NUMBER 234-75 BE AMENDED BY THE DELETION THEREFROM OF THE FOLLOWING UNDER THE APPROPRIATE COLUMNS THEREOF.

HOWDEN BLVD.	SOUTH	A POINT 720 FEET WEST OF CENTRAL PARK DRIVE TO A POINT 920 FEET WEST OF CENTRAL PARK DRIVE.	ST. JEAN BREBEUF

2. THAT SCHEDULE "A" TO BY-LAW NUMBER 234-75 BE AMENDED BY THE ADDITION OF THE FOLLOWING, UNDER THE APPROPRIATE COLUMNS THEREOF.

<u>COLUMN 1</u> <u>HIGHWAY</u>	<u>COLUMN 2</u> <u>SIDE</u>	<u>COLUMN 3</u> <u>FROM</u>	<u>COLUMN 4</u> <u>SCHOOL OR</u> <u>INSTITUTION</u>
CAMPBELL DRIVE	SOUTH	A POINT 9 METRES EAST OF FAIRFIELD AVENUE TO A POINT 54 METRES EAST OF FAIRFIELD AVENUE.	BEATTY-FLEMING SCHOOL
CAMPBELL DRIVE	SOUTH	A POINT 15 METRES WEST OF FAIRFIELD AVENUE TO A POINT 81 METRES WEST OF FAIRFIELD AVENUE.	BEATTY-FLEMING SCHOOL

3. THE PROVISIONS OF THIS BY-LAW SHALL NOT BECOME EFFECTIVE UNTIL APPROVED BY THE COUNCIL OF THE REGIONAL MUNICIPALITY OF PEEL.
