Number 15-94

To amend By-law 93-93 to regulate use of highways and parking in the City of Brampton

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from the specified columns of Schedule III thereto the following items:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Goreway Drive	The south limit of Countryside Drive and the north limit of Castlemore Road
Goreway Drive	The south limit of Castlemore Road and the southerly border of the City of Brampton
Mountainash Road	The north limit of the road and the north limit of Bovaird Drive
Sunforest Drive	The north limit of the road and the north limit of Wexford Road

(2) by deleting from the specified columns of Schedule IV thereto the following items:

STOP SIGNS

Castlemore Road and Goreway Drive	Northbound on Goreway Drive

(3) by deleting from the specified columns of Schedule XIV thereto the following item:

(5) by adding to the specified columns of Schedule IV thereto the following items:

2. Subsections 1 (1), (2), (4), (5), and (6) of this by-law shall not come into force until approved by the council of The Regional Municipality of Peel.




