

MEMORANDUM OF AGREEMENT made in duplicate  
this 26th day of January 1976

B E T W E E N :

THE CORPORATION OF THE CITY OF BRAMPTON

hereinafter called the 'City'

OF THE FIRST PART

A N D

BRUCE HARPER

hereinafter called the "Ice Maker"

OF THE SECOND PART

The City hereby agrees to retain the services of  
Mr. Bruce Harper as Ice Maker of the Chinguacousy Curling Rink  
on the following terms and conditions:

1. The term of this contract shall be from the 1st day of January 1976 to the 24th day of April 1976 and the City agrees to pay to Mr. Bruce Harper the sum of Two Hundred and Twenty Dollars (\$220.00) for each week during the aforesaid term in which he satisfactorily performs the functions of Ice Maker as set out herein at such times as the said services are required between the hours of 7 a.m. and 5 p.m. each day, Monday to Friday inclusive, of each week.
2. The Ice Maker shall be responsible to the Manager for the preparation and efficient maintenance of an acceptable curling ice surface and shall carry out all duties pertaining thereto.
3. The Ice Maker shall carry out other duties as assigned by the Manager as and when required in connection with the operation of the curling rink.


4. This contract shall continue for the term set out above except that it may be terminated prior to the expiration of the term set out above by either party for just cause.



MEMORANDUM OF AGREEMENT made in duplicate  
this 26th day of January 1976

B E T W E E N :

THE CORPORATION OF THE CITY OF BRAMPTON  
hereinafter called the 'City'

OF THE FIRST PART

A N D

ALEC WINSLOW  
hereinafter called the 'Manager'

OF THE SECOND PART

The City hereby agrees to retain the services of  
Mr. Alec Winslow as manager of the Chinguacousy Curling Rink  
upon the following terms and conditions;

1. The term of this contract shall be from the 1st  
day of January 1976 to the 1st day of July 1976 and the City  
agrees to pay to Mr. Alec Winslow the contract sum of Seven  
Thousand and Twelve Dollars and Fifty Cents (\$7,012.50) for  
the aforesaid period provided he satisfactorily performs the  
function of manager in accordance with the terms of this con-  
tract.

2. The said contract sum shall be paid in equal pay-  
ments on the 15th and last day of each month during the term  
of this agreement. In addition the City shall forward to  
the Manager at the appropriate dates cheques in the proper  
amount to pay the Manager's O.H.I.P. premiums during the term  
of this contract.

3. The Manager shall be responsible to the City Superintendent of Facilities for the efficient operation of the curling rink and the direction and supervision of part-time help and other persons under contract to the City to perform services within the curling rink.

4. The Manager shall be responsible for the requisitioning of materials, supplies or repairs through the central Purchasing Department of the City and the Manager shall also be responsible for the supervision and preparation of records, work schedules, time and revenue sheets and for the scheduling of rinks and social functions within the curling rink.

5. The Manager shall, during the term of this contract, devote the whole of his time and attention to the business of the curling rink and shall not engage in any other business or occupation other than as set out in this contract. Where possible the Manager shall provide instruction in curling to participants at the rink but this shall be construed as part of the managerial duties and no financial compensation for such instruction shall be solicited or received.


6. The Manager shall be entitled to operate the "Pro Shop" within the curling rink and the Manager shall be responsible for all debts and expenses of the said Pro Shop and shall be entitled to the net profits from the Pro Shop. It is understood and agreed between the parties hereto that the Pro Shop shall be under the sole jurisdiction of the Manager, and that the City shall have no responsibility with regard to the operation of the Pro Shop.

7. This contract shall continue for the term set out above except that it may be terminated prior to the expiration of the term set out above by either party for just cause.



Rink on the following terms and conditions:

1. The term of this contract shall be from the 1st  
day of January 1976 to the 24th day of April 1976 and the City  
agrees to pay to Mr. John Bull the sum of One Hundred and  
Ninety Dollars (\$190.00) for each week during the aforesaid  
term in which he satisfactorily performs the functions of  
Maintenance Man as set out herein.


2. The Maintenance Man shall be responsible to the  
Manager for the cleanliness and general upkeep of the curling  
rink and for the performance of other duties as assigned.  
He shall report any requirements of supplies, material,  
services or repairs to the Manager.


3. The Maintenance Man shall be on duty as and when required by the Manager to provide a well maintained and clean facility.

4. This contract shall continue for the term set out above except that it may be terminated prior to the expiration of the term set out above by either party for just cause.



The City hereby agrees to retain the services of Norma Carrier as Secretary of the Chinguacousy Curling Rink on the following terms and conditions:



The term of this contract shall be from the 1st day of January 1976 to the 24th day of April 1976 and the City agrees to pay to Norma Carrier the sum of Eighty-Five Dollars (\$85.00) for each week during the aforesaid term in which she satisfactorily performs the functions of Secretary as set out herein.

2. The Secretary shall be responsible to the Manager for the preparation of correspondence, records and reports and for public reception, clerical and general office duties and shall carry out other duties as assigned by the Manager but in no event shall she be required to devote more than thirty (30) hours per week to the services provided for in this contract.


3. This contract shall continue for the term set out above except that it may be terminated prior to the expiration date of the term set out above by either party for just cause.


