A By-law to Amend By-law 191-2003, as amended,
being a By-law to Appoint a Chief Building Official
and Inspectors for the Enforcement of the
Building Code Act, 1992 and its Regulations and Municipal By-laws

WHEREAS subsection 3(2) of the *Building Code Act, 1992*, S.O. 1992 c.23 requires the Council of each municipality to appoint a Chief Building Official and such inspectors as are necessary for the purposes of the enforcement of the *Building Code Act, 1992*;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. Section 3 of By-law 191-2003 is hereby amended as follows:

(1) N. Ali is hereby appointed as an inspector pursuant to subsection 3(2) of the *Building Code Act, 1992* (and regulations thereunder) in the City of Brampton.

2. Attached hereto as Schedule "A" is an up-to-date list of inspectors' names.
