To accept and assume works in Registered Plan 43M-1008;
and Part of Lot 14, Concession 3 E.H.S. (designated as Westcreek
Boulevard by By-law No. 213-98, INST. LT1871263) designated
as Parts 1 to 4, both inclusive, on Reference Plan 43R-25657

WHEREAS the Council of The Corporation of the City of Brampton has, by resolution, decided that all works constructed and installed in accordance with the subdivision agreement for Registered Plan 43M-1008 and Part of Lot 14, Concession 3, E.H.S. (designated as Westcreek Boulevard by By-law No. 213-98, INST. LT1871263) designated as Parts 1 to 4, both inclusive, on Reference Plan 43R-25657 be accepted and assumed;

AND WHEREAS Council has authorized the City Treasurer to release the securities held by the City in connection with the registered plan and reference plan;

AND WHEREAS it is deemed expedient to accept and assume the streets on Registered Plan 43M-1008 and Part of Lot 14, Concession 3, E.H.S. (designated as Westcreek Boulevard by By-law No. 213-98, INST. LT1871263) designated as Parts 1 to 4, both inclusive, on Reference Plan 43R-25657 as part of the public highway system.

NOW THEREFORE the Council of The Corporation of the City of Brampton hereby **ENACTS** as follows:

1. All of the works constructed and installed in accordance with the subdivision agreement for Registered Plan 43M-1008 and Part of Lot 14, Concession 3, E.H.S. (designated as Westcreek Boulevard by By-law No. 213-98, INST. LT1871263) designated as Parts 1 to 4, both inclusive, on Reference Plan 43R-25657 are hereby accepted and assumed.
2. The streets described in Schedule A to this by-law are hereby accepted and assumed as part of the public highway system of the City of Brampton.
