

SCHEDULE 'B' OF BY-LAW NUMBER 22-77 CITY OF BRAMPTON

Maximum Building Area above grade except for canopies, ventilated housings, ramps and stairs, to be within Apartment Building Area as shown on Schedule 'A', subject to gross floor area.

No ingress or egress for motor vehicles except as indicated by arrows(  $\leq$  ) as shown on Schedule 'A'.

Landscaped area to include any surfaced walk or patio, any tennis or badminton court, tot lot or similar sports or recreation area, or any swimming or decorative pool, providing these are at grade or on the roof of an underground garage.
