# BY-LAW

*Number* 24-2002

**To amend By-law 93-93,  
STOP SIGNS, THROUGH HIGHWAYS**

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by adding to Schedule IV thereto the following items:

Red River Drive	The east limit of Sunny Meadow Boulevard and the west limit of Barleyfield Road



Red River Drive	The west limit of Alberta Terrace and the east limit of Flatlands Way


