The council of The Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 861, as amended, is hereby further amended:
 - (1) by deleting therefrom section 324.1.1(2), and substituting therefor:
 - "(2) business or professional offices, including offices for health care practitioners;"
 - (2) by adding the following to section 324.1.1:
 - "(11) retail establishments."
 - (3) by adding the following to section 324.1.2:
 - "(16) the gross commercial floor area of all offices for health care practitioners shall not exceed 185 square metres."
 - (4) by adding the following to section 324.2:

"AMUSEMENT ARCADE shall mean any shop, building or place in which amusement devices are installed, placed or operated as the principal trade.

RETAIL ESTABLISHMENT shall mean a building or place where goods or materials are sold or kept for sale to the general public, but shall not include beer stores, liquor stores, amusement arcades, or stores that sell goods which appeal to erotic tastes."
