Schedule I – Finance – is hereby amended under "Tax" as follows:

- To change the fee for "Land/Property Ownership Change" from \$25.00 to \$30.00
- To add the following fees:
 - o "Retrieval and Return of Post Dated Cheques (Lockbox) per cheque" \$15.00
 - o "Capping / Clawback Calculation Summary (per year requested)" \$10.00
 - o "WSIB Collection Accounts Administration Fee per account" 5%
