# BY-LAW

Number 29-2013

**A By-law to Amend User Fee By-law 380-2003, as amended**

WHEREAS By-law 380-2003 was passed pursuant to the *Municipal Act, 2001*, s. 391 (1) to impose fees or charges;

NOW THEREFORE the Council of the Corporation of the City of Brampton ENACTS as follows:

1. Schedule H, Engineering and Traffic Division Fees/Charges, Works and Transportation Department of By-law 380-2003, as amended, is hereby further amended as follows:

- (1) by REPEALING from Schedule H thereto the following items:


