#### MEMORANDUM OF AGREEMENT made in duplicate this

1st day of December, A.D. 1976.

BETWEEN:

BRAMALEA LIMITED (hereinafter called the 'Owner') OF THE FIRST PART

AND

#### THE CORPORATION OF THE CITY OF BRAMPTON

(hereinafter called the 'City') OF THE SECOND PART

WHEREAS the Owner warrants that it is the owner of the lands shown on a survey annexed hereto as Schedule "A";

AND WHEREAS an agreement was entered into between Bramalea Consolidated Developments Limited, the Corporation of the City of Brampton and the Regional Municipality of Peel dated the 10th day of November, 1975;

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the covenants herein contained, the parties hereto agree each with the other as follows:

1. The agreement dated the 10th day of November, 1975 as recited above shall remain in full force and effect except for the following additional covenants between the parties hereto.

2. The parties agree that the lands shown on Schedule "A" shall be developed and the units thereon marketed under a condominium corporation. The Owner agrees and undertakes to

file with the City of Brampton, prior to condominium registration, the proposed by-laws and declarations for the condominium corporation; which by-laws and declarations shall be consistent with the approved site plans for the development of the lands shown on Schedule "A" and, so far as possible, the City of Brampton condominium policy.

3. The owner agrees that all private streets shown on Schedule "A" shall be named with names to be approved by the City and the Regional Municipality of Peel and the Owner agrees to erect street name signs on the private streets shown on Schedule "A" and on the abutting public streets in locations and in accordance with specifications to be approved by the City Engineer.


4. The covenants, agreements, conditions and undertakings herein contained on the part of the owner shall run with the lands and shall be binding upon it and upon its successors and assigns and shall be appurtenant to the adjoining highway in the ownership of the City of Brampton.
