## **BY-LAW**

To change the name of Davidson Road

WHEREAS The Council of The Corporation of the City of Brampton deems it expedient to change the name of Davidson Road;

AND WHEREAS notice of the intention to pass a by-law changing the name of Davidson Road has been published once a week for four successive weeks in the Daily Times, a newspaper having general circulation in the City of Brampton;

AND WHEREAS on the 13th day of August, 1984, the Council heard all persons who claimed that they would be adversely affected by this by-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

 The name of the street known as "Davidson Road", which is described in Schedule A hereto, is changed to "Clark Boulevard".

2. By-laws 196-84 and 197-84 are hereby repealed. READ A FIRST, SECOND AND THIRD TIME AND PASSED IN OPEN COUNCIL THIS 11th DAY OF February , 1985.

## SCHEDULE A TO BY-LAW 30-82 LANDS COMPRISING DAVIDSON ROAD

The land situated in the City of Brampton, in the Regional Municipality of Peel, (formerly in the Township of Chinguacousy, in the County of Peel), being composed of:

- FIRSTLY: the whole of Davidson Road, according to a plan of subdivision registered in the Land Registry Office for the Registry Division of Peel (No. 43) as number 644;
- <u>SECONDLY</u>: the whole of a one foot reserve at the northeasterly end of Davidson Road, according to said Registered Plan 644;
- THIRDLY: the part of Lot 5 according to said Registered Plan 644, designated as Part 2 on a reference plan deposited in the Land Registry Office for the Registry Division of Peel (No. 43) as number 43R-11453;
- <u>FOURTHLY</u>: the part of Lot 9 according to said Registered Plan 644, designated as Part 1 on said Reference Plan 43R-11453;
- FIFTHLY: the part of Lot 8 according to said Registered Plan 644, designated as Part 3 on said Reference Plan 43R-11453;
- <u>SIXTHLY</u>: the part of the East half of Lot 5, Concession 2, East of Hurontario Street, designated as Part 1 on a reference plan deposited in the Land Registry Office for the Registry Division of Peel (No. 43) as number 43R-5553; and
- <u>SEVENTHLY</u>: the part of the East half of Lot 5, Concession 2, East of Hurontario Street, designated as Part 6 on said Reference Plan 43R-5553.
