BY-LAW

Number 30-2012

To amend Traffic By-law 93-93 by amending the Schedules relating to U-TURNS (Schedule II), FIRE ROUTES (Schedule XXII), THROUGH HIGHWAYS (Schedule III), STOP SIGNS (Schedule IV) and RATE OF SPEED (Schedule X)

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended as follows:
 - (1) by adding to Schedule II thereto the following item:

U-TURNS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Jefferson Drive	Juniper Crescent and Jacobs Square

- (2) by adding to Schedule XXII thereto the following items:

FIRE ROUTES

- (3) by removing from Schedule III thereto the following item:

(4) by adding to Schedule III thereto the following items:

Bleasdale Avenue	The south limit of James Potter Road and the north limit of Sidford Road/Klemscott Road
Bleasdale Avenue	The south limit of Sidford Road/Klemscott Road and the north limit of Commuter Drive (southerly intersection)

(5) by adding to Schedule IV thereto the following items:

Bleasdale Avenue and Sidford Road/Klemscott Road	Westbound on Klemscott Road

(6) by removing from Schedule X thereto the following item:

RATE OF SPEED

Cloverdale Drive	40	Clark Boulevard and a point 121 metres north of Cathcart Crescent (northerly intersection)	Anytime

(7) by adding to Schedule X thereto the following item:

RATE OF SPEED

COLUMN 1 HIGHWAY	COLUMN 2 RATE OF SPEED	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAY
Cloverdale Drive	40	A point 121 metres north of Cathcart Crescent (northerly intersection) and Balmoral Drive	Anytime
