WHEREAS it is deemed expedient to accept and assume certain streets and lands shown on Registered Plan M-100 as public highways;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. The land described in Schedule A to this by-law be and the same is hereby accepted and assumed as part of the public highway system of the City of Brampton.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 22nd day of February , 1982.

SCHEDULE A TO BY-LAW 31-82

FIRSTLY: the whole of the part of Conestoga Drive shown on a plan of subdivision registered in the Land Registry Office for the Land Titles Division of Peel (No. 43) as M-100;

SECONDLY: the whole of the part of Sandalwood Parkway shown on the said Registered Plan M-100;

THIRDLY: the whole of Block D, according to the said Registered Plan M-100; (to be part of Kennedy Road North)

FOURTHLY: the whole of Block E, according to the said Registered Plan M-100.

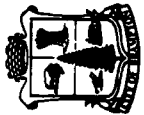
