The council of The Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 139-84, as amended, is hereby further amended:
 - (1) by changing, on Sheet 9 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from INDUSTRIAL ONE ZONE (M1) to INDUSTRIAL ONE ZONE SECTION 664 (M1 SECTION 664).
 - (2) by adding thereto the following section:
 - "664. The lands designated Ml SECTION 664 on Sheet 9 of Schedule A to this by-law.
 - 664.1 shall only be used for the following purposes:
 - (1) the purposes permitted in the M1 zone by section 31.1.1;
 - (2) a standard restaurant only in conjunction with the manufacturing, cleaning, packaging or processing of foods within an enclosed building.
 - 664.2 shall be subject to the following requirements and restrictions:
 - (1) the purpose permitted by section 664.1(2) (standard restaurant) shall not exceed a gross floor area of 130 square metres.

- (2) an adult entertainment parlour shall not be permitted in conjunction with the purpose permitted by section 664.1(2) (standard restaurant).
- shall also be subject to the restrictions and requirements relating to the Ml zone and all of the general provisions of this by-law which are not in conflict with the ones set out in section 664.2.

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL, this 9th day of February , 1987.


