

The Council of the Corporation of the City of Brampton ENACTS as follow:


1. By-law 151-88, as amended, is hereby further amended:

OPEN COUNCIL, this 11th day of February 2002.

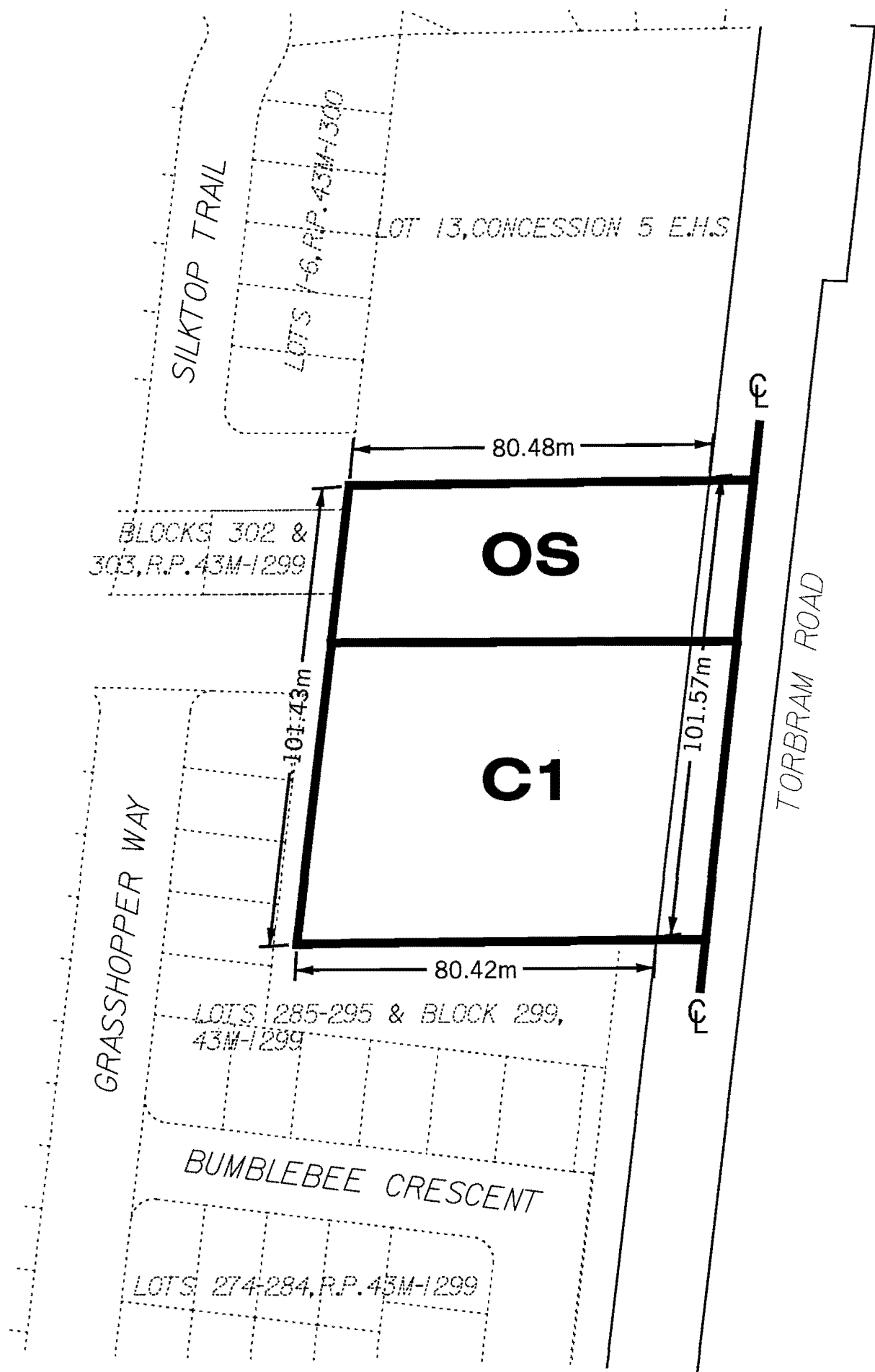

-  METRES



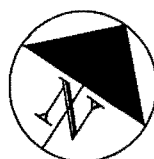


