- the whole of Royal Palm Drive, as shown on said Registered Plan M-111;
- the whole of Rushmore Crescent, as shown on said Registered Plan M-111;
- 9. the whole of the part of Sandalwood Parkway East (which street name was changed from Sandalwood Parkway by By-law 239-82, passed on 22 November 1982 and registered at the said Land Registry Office on 6 December 1982 as Instrument No. 406067) shown on the said Registered Plan M-111.
