To amend By-law 93-93,
RATE OF SPEED,
SCHOOL BUS LOADING ZONE,
AND NO STOPPING

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from Schedule X thereto the following item:

RATE OF SPEED

COLUMN 1 HIGHWAY	COLUMN 2 RATE OF SPEED	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
McLaughlin Road North	60	Canadian Pacific Railway tracks and the southerly limit of the City of Brampton	Anytime

(2) by adding to Schedule X thereto the following items:

RATE OF SPEED

COLUMN 1 HIGHWAY	COLUMN 2 RATE OF SPEED	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Malta Avenue	40	Tina Court and a point 181 metres south of Sir Lou Drive	Anytime
McLaughlin Road South	60	Queen Street and the southerly limit of the City of Brampton	Anytime

(3) by adding to Schedule VIII thereto the following items:

SCHOOL BUS LOADING ZONE

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 SCHOOL OR INSTITUTION
Aloma Crescent	North	A point 145 metres north/west of Albion Crescent (east intersection) and a point 87 metres north/west of Albion Crescent (east intersection)	Aloma Public School
Sunset Boulevard	West	A point 65 metres north of Elmgrove Avenue and a point 45 metres north of Elmgrove Avenue	Glendale Public School

(4) by adding to Schedule XV thereto the following item:

NO STOPPING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Aloma Crescent	Inside	A point 137 metres north of Albion Crescent (west intersection) and Albion Crescent (east intersection)	8:00 am to 5:00 pm Monday to Friday

2. Subsections (1), (2) and (3) of this by-law shall not come into force until approved by the council of the Regional Municipality of Peel



To amend By-law 93-93, RATE OF SPEED, SCHOOL BUS LOADING ZONE, AND NO STOPPING

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from Schedule X thereto the following item:

RATE OF SPEED

COLUMN 1 HIGHWAY	COLUMN 2 RATE OF SPEED	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
McLaughlin Road North	60	Canadian Pacific Railway tracks and the southerly limit of the City of Brampton	Anytime

(2) by adding to Schedule X thereto the following items:

Malta Avenue	40	Tina Court and a point 181 metres south of Sir Lou Drive	Anytime
McLaughlin Road South	60	Queen Street and the southerly limit of the City of Brampton	Anytime

(3) by adding to Schedule VIII thereto the following items:

SCHOOL BUS LOADING ZONE

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 SCHOOL OR INSTITUTION
Aloma Crescent	North	A point 145 metres north/west of Albion Crescent (east intersection) and a point 87 metres north/west of Albion Crescent (east intersection)	Aloma Public School
Sunset Boulevard	West	A point 65 metres north of Elmgrove Avenue and a point 45 metres north of Elmgrove Avenue	Glendale Public School

(4) by adding to Schedule XV thereto the following item:

NO STOPPING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Aloma Crescent	Inside	A point 137 metres north of Albion Crescent (west intersection) and Albion Créscent (east intersection)	8:00 am to 5:00 pm Monday to Friday

2. Subsections (1), (2) and (3) of this by-law shall not come into force until approved by the council of the Regional Municipality of Peel
