To amend By-law 93-93,

NO STOPPING PARKING METERS (ON-STREET)

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from Schedule XV thereto the following items:

NO STOPPING

Queen Street East	South	A point 25 metres west of Chapel Street and James Street	Anytime

(3) by deleting from Schedule XX thereto the following item:

Queen Street East	South	A point 79 metres east of Main Street South and a point 25 Metres west of Chapel Street	15 min for each 25 cent piece 60 min for each 1 dollar piece	60 Minutes	9:00am-4:00pm Monday-Friday 9:00am-6:00pm Saturday
