BY-LAW

Number 51-2004

A by-law to amend Fee By-law 380-2003, to repeal By-law 265-96, and to amend By-laws 7-92 and 261-93

WHEREAS By-law 380-2003 was passed pursuant to the *Municipal Act, 2001, c. 25, S. 391(1)* to impose fees or charges;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. That By-law 380-2003 is hereby amended by the adding Schedules 1 through 8 to this bylaw as Schedules B through I as follows:

- Schedule B – Legal Services Department
- Schedule C – City Clerk’s Office
- Schedule D – Animal Services Division
- Schedule E – Economic Development Office
- Schedule F – Fire and Emergency Services Division
- Schedule G – Transit Division
- Schedule H – Engineering and Traffic Sections of Works and Transportation Department
- Schedule I – Finance Department




