**To amend By-law 93-93,
THROUGH HIGHWAYS, RATE OF SPEED,
NO PARKING, FIRE ROUTES, HEAVY TRUCKS**

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from Schedule III thereto the following items:
