# BY-LAW

*Number* 54-2002  
To amend By-law 93-93,

## NO PARKING, NO STOPPING THROUGH HIGHWAYS, STOP SIGNS, SECTION 53.1 (TEXT)

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from Schedule XIV thereto the following item:

### NO PARKING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Gretna Drive	East	Kimbark Drive and Campbell Drive	Anytime

(2) by adding to Schedule XIV thereto the following item:

### NO PARKING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Gretna Drive	East	Horwood Drive and Campbell Drive	Anytime

(3) by adding to Schedule XV thereto the following item:

### NO STOPPING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Gretna Drive	West	Kimbark Drive and Horwood Drive	Monday-Friday 8:00a.m.-6:00p.m.

(4) by adding to Schedule III thereto the following items:

**THROUGH HIGHWAYS**

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Burnt Elm Drive	East limit of Van Kirk Drive and the north limit of Van Scott Drive
Milkweed Crescent	East limit of Burnt Elm Drive and the east limit of Van Scott Drive
Tinsmith Street	South limit of Van Scott Drive and the north limit of Steeprock Road
Twin Pines Crescent	South limit of Van Scott Drive and the north limit of Steeprock Road
Van Scott Drive	East limit of Van Kirk Drive (southerly intersection) and the east limit of Coppermill Drive
Van Scott Drive	North limit of Milkweed Crescent and the south limit of Sunny Glen Crescent
Van Scott Drive	East limit of McLaughlin Road and the west limit of Van Kirk Drive
Van Scott Drive	East limit of Van Kirk Drive (northerly intersection) and the east limit of Burnt Elm Drive
Viceroy Crescent	East limit of Van Kirk Drive (northerly intersection) and the south limit of Stable Gate
Wandering Trail Drive	West limit of Van Kirk Drive and the north limit of Van Scott Drive

(5) by adding to Schedule IV thereto the following items:

**STOP SIGNS**

COLUMN 1 INTERSECTION	COLUMN 2 FACING TRAFFIC
Winners Circle and Winners Circle	Westbound on Winners Circle
Winners Circle and Cedar Valley Boulevard	Westbound on Cedar Valley Boulevard
Van Scott Drive and Tinsmith Street and Twin Pines Crescent	Northbound on Tinsmith Street
Van Scott Drive and Tinsmith Street and Twin Pines Crescent	Southbound on Van Scott Drive
Van Scott Drive and Narcissus Gate	Northbound on Van Scott Drive

(6) by deleting from by-law 93-93 the following section:

“53.1 Where signs to that effect are displayed, no person shall cause or permit a vehicle to stop, stand or park while idling for a period exceeding three (3) minutes on a highway at the side between the limits set out respectively in Columns 1, 2 and 3 of Schedule 29 of this by-law.”

(7) by adding to by-law 93-93 the following section:

"53.1 Where signs to that effect are displayed, no person shall cause or permit a vehicle to stop, stand or park while idling for a period exceeding three (3) minutes on any highway and between the limits set out respectively in Columns 1 and 2 of Schedule XXIX of this by-law during the prohibited times or days set out in Column 3 of the said Schedule."
