To amend By-law 151-88, as amended,
(Part of Lot 12, Concession 2, E.H.S., in the
geographic Township of Chinguacousy)

The council of The Corporation of the City of Brampton ENACTS
as follows:

1. By-law 151-88, as amended, is hereby further amended:

- (1) by changing on Sheet Number 26E of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from RESIDENTIAL SINGLE FAMILY C (HOLDING) - SECTION 370 (R1C(H) - SECTION 370) to RESIDENTIAL SINGLE FAMILY C - SECTION 370 (RIC - SECTION 370), such lands being Part of Lot 12, Concession 2, East of Hurontario Street, in the geographic Township of Chinguacousy.

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN
COUNCIL, this 13th day of April 1992.

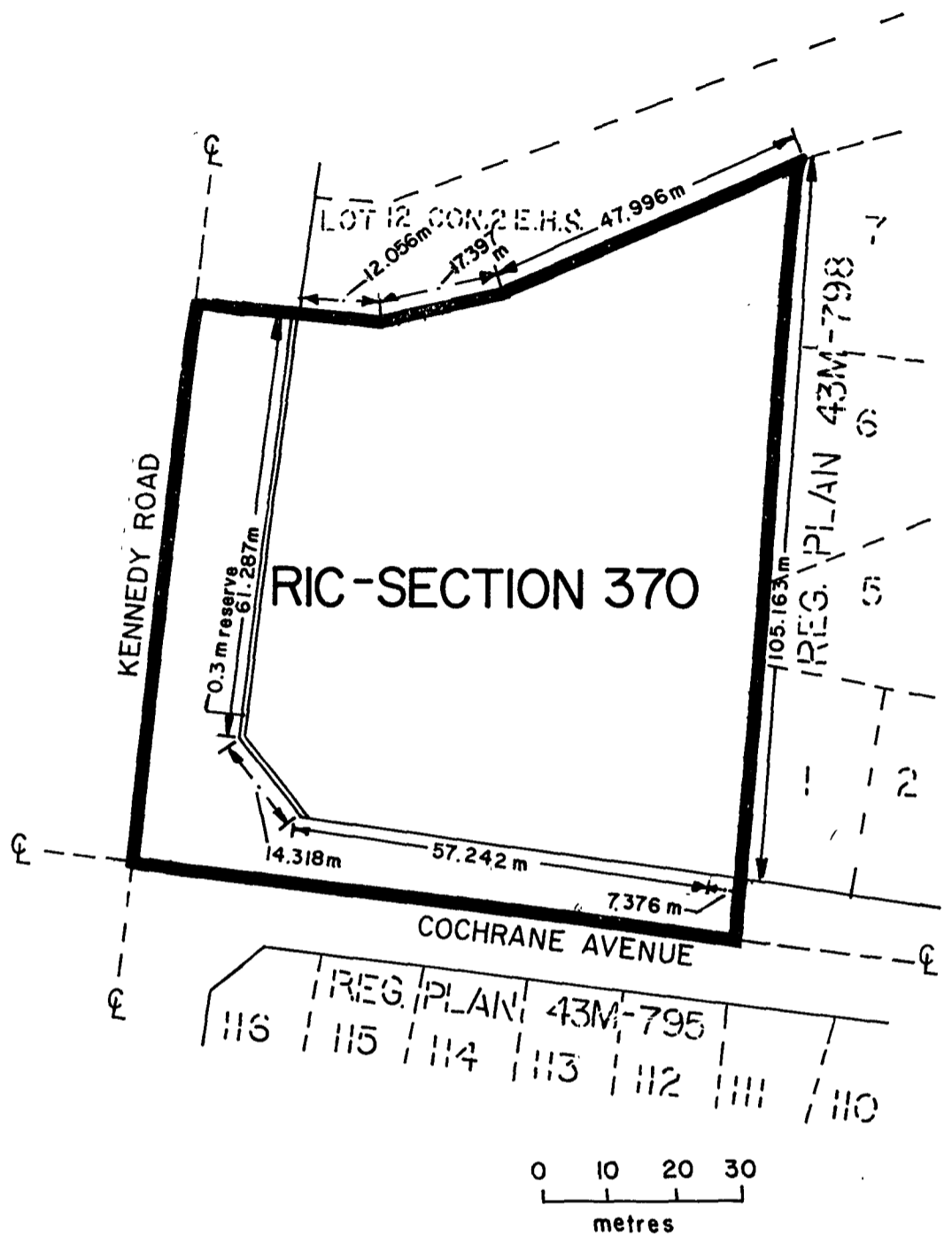
