WHEREAS Subsection 7 of Sections 66 and 77 of The Highway Traffic Act (R.S.O. 1970, Chapter 202) provides that:-

The Council of a City or separated Town may, by By-law, declare the provisions of Subsections 4 and 5 to be in force in respect of Highways within the City or separated Town;

AND WHEREAS restriction of loads is deemed necessary for the protection of certain Highways in the Corporation of the City of Brampton;

NOW THEREFORE the Council of the Corporation of the City of Brampton ENACTS as follows:

- (1) The provisions of Subsections 4 and 5 of Sections 66 and 77 of The Highway Traffic Act shall extend and apply to the Highway set out in Column 1 of Schedule "A" to this By-law between the limits set out in Column 2 of the said schedule.
- (2) The penalties provided in Subsection 6 of Sections 66 or 77 shall apply to offences against this By-law.

- (3) This By-law shall not become effective until approved by the Council of the Regional Municipality of Peel; and until appropriate signs have been erected and are on display.
- (4) Town of Brampton By-law Number 1946 is hereby repealed.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 23rd day of February, 1976.
