

THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number _____58-89

To authorize a Capital Expenditure in the amount of \$14,600,000 for the acquisition and purchase of land for Brampton Hydro Electric Commission and the construction of a Municipal Substation. OMB E890096

The Council of the Corporation of the City of Brampton ENACTS as follows:

- 1. THAT the Council of the Corporation of the City of Brampton shall undertake the acquisition of lands on Sandalwood Parkway just west of Highway 10, more particularly described as Part of Lot 13, Concession 1, W.H.S. to consolidate Brampton Hydro-Electric Commission's two operations at one location and the construction of a municipal substation in the area Dixie Road/Clark Boulevard.
- 2. The Mayor and Clerk are hereby authorized in the name of and on behalf of The Corporation of the City of |Brampton to borrow from time to time by way of promissory note from The Royal Bank of Canada, 1 Main Street North, Brampton, a sum or sums not exceeding in the aggregate \$14,600,000 for the works described in Schedule A, and to give, on behalf of The Corporation of the City of Brampton, a promissory note or notes sealed with the Corporate Seal and signed by the Mayor and the Treasurer for the money so borrowed with interest which may be paid in advance or otherwise.
- 3. Where the Treasurer feels it would be in the best interest of the Corporation, he may direct that all or part of the aggregate sum set out in Section 2 be borrowed from Corporation Reserve Funds rather than from The Royal Bank of Canada, provided that the total amounts borrowed from The Royal Bank of Canada and Corporation Reserve Funds do not exceed the aggregate set out in Section 2. The Mayor and Treasurer are hereby authorized to execute under corporate seal any promissory notes or other documentation required in connection with borrowing from Corporation Reserve Funds pursuant to this Section.
- 4. The Clerk is hereby instructed to request the Council of The Regional Municipality of Peel to pass a by-law authorizing the issue and sale of debentures for the purposes set out in Schedule A, in an amount not to exceed \$7,500,000.
- 5. This by-law shall not take effect until the approval of the Ontario Municipal Board under Section 64(8) of the Ontario Municipal Board Act has been obtained.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 13th day of March, 1989.
