TO THE OFFICIAL PLAN OF THE
CITY OF BRAMPTON PLANNING AREA

1.0 Purpose

The purpose of this amendment is to set out secondary plan provisions for Secondary Plan Area 43 (Fletchers Creek Village) within Brampton's 1993 Official Plan.

2.0 Location

The lands subject to this amendment comprise approximately 161 hectares (400 acres) and are generally located between McLaughlin Road and Chinguacousy Road south of Highway 7 and north of the Canadian National Railway. The lands are described as being part of Lots 8, 9, and 10, Concession 2 W.H.S., in the geographic Township of Chinguacousy, now in the City of Brampton.

3.0 Amendment and Policies Relative Thereto

3.1 Amendment Number 260 :

1. The document known as the 1993 Official Plan of the City of Brampton Planning Area is hereby amended:
 - (i) by deleting therefrom, under Part II: Secondary Plans, Area 43: Fletchers Creek Village, the following:
"No Secondary Plan in place."
 - (ii) by adding thereto, under Part II: Secondary Plans, Area 43: Fletchers Creek Village, the following:
"Chapter 43 of Part IV of the 1984 Official Plan, as it applies to Secondary Plan Area Number 43, shall constitute the Fletchers Creek Village Secondary Plan."
