To amend By-law 93-93, RATE OF SPEED, SCHOOL BUS LOADING ZONE, NO PARKING AND NO STOPPING

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

- 1. By-law 93-93, as amended, is hereby further amended as follows:
 - (1) by adding to Schedule VIII thereto the following item:


2. Subsections (1) and (2) of this by-law shall not come into force until approved by the council of the Regional Municipality of Peel.
