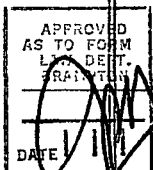
To amend By-law 139-84 (Block  
217, R.P. 43M-614)

The council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 139-84, as amended, is hereby further amended by changing, on Sheet 7 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from INSTITUTIONAL ONE (I1) to RESIDENTIAL SINGLE FAMILY C - SECTION 572 (R1C - SECTION 572), RESIDENTIAL SINGLE FAMILY C - SECTION 573 (R1C - SECTION 573), RESIDENTIAL SINGLE FAMILY D - SECTION 570 (R1D - SECTION 570), and OPEN SPACE (OS).

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL,
