
BY-LAW NUMBER 60-75


A By-law to accept and assume lands  
as part of a public highway in the  
City of Brampton.

WHEREAS it is deemed expedient to accept and assume lands  
in conveyance and dedicate same as parts of public highway;  
NOW THEREFORE the Council of the Corporation of the City  
of Brampton ENACTS as follows:

1. The land described in deeds of  
conveyance to the Corporation of  
the City of Brampton listed on  
Schedule "A" hereto attached, be  
and the same are hereby accepted  
and the said lands are assumed as  
part of the public highway adjacent  
thereto, as indicated on Schedule "A".

READ a FIRST, SECOND and THIRD TIME and PASSED in OPEN COUNCIL

All and singular that certain parcel or tract of land and premises situate, lying and being in the City of Brampton, in the Regional Municipality of Peel (formerly in the Township of Chinguacousy) County of Peel and being composed of that part of Blocks A, B, C, and D Registered Plan 640 designated as Part 3 on Reference Plan deposited in the Registry Office for the Registry Division of Peel as Plan No. 43R-1470 (Part of Orenda Road)

THIRDLY:

All and singular that certain parcel or tract of land and premises situate, lying and being in the City of Brampton, in the Regional Municipality of Peel (formerly in the Township of Chinguacousy) County of Peel and being composed of that part of Block C Registered Plan 640 designated as Parts 9, 13, 14, 15, 16 and 17 on Reference Plan deposited in the Registry Office for the Registry Division of Peel as Plan No. 43R-1469 (Part of Orenda Road)
